1. Overview


This privacy brochure provides a high-level outline for privacy considerations in the Sitecore OrderCloud® product offering.

2. Product description

Sitecore OrderCloud is a "headless" e-commerce and order management platform delivered as a cloud service and exposed entirely via a REST API. It offers the scalability to match the current and future needs of customers, including: (1) operating at the high performance, customizability, and control to meet unique buyers' expectations; (2) the extensibility to both connect to new systems and extend commerce experiences to new channels, and (3) the agility and speed to respond to changing customer expectations. In short, in today's ever-changing commerce landscape, Sitecore OrderCloud empowers organizations to achieve their own unique digital commerce platform business needs.

3. Personal data processing

The diagram below shows the flow of data through Sitecore OrderCloud's environment.





The table below lists the personal data processed by Sitecore OrderCloud to provide its services and describes why the data is processed. As the data controller, Sitecore's customer is responsible for the data which they import into Sitecore OrderCloud. The Sitecore OrderCloud base schema is extensible, and therefore the precise category of data transmitted, processed, or stored by Sitecore is determined by the data controller (Sitecore customer). Please note, however, that for the provision of the services purchased from Sitecore, no sensitive data should be shared.

4. Storage of your data

Sitecore OrderCloud leverages third-party cloud hosting providers to provide services globally, utilizing the Azure SQL Database service to fulfill the multi-tenant architecture of the application.

Sitecore OrderCloud uses Microsoft Azure as a Cloud Service Provider for storing data associated with providing its services. Sitecore OrderCloud operates Azure data centers in Europe, United States, Japan, and Australia.

5. Sitecore OrderCloud access to your data

Access to customer data is highly regulated. In general, only select Sitecore personnel have direct access to customer data, primarily for troubleshooting customer support inquiries or addressing service-related issues, where applicable.



8. General security

Sitecore OrderCloud aligns to ISO27001 and has implemented measures to transport, transmit, and communicate or store data on data media (manual or electronic) and for subsequent checking (e.g., database security, transmission security), including encryption, DLP, and data segregation.




Figure 3: Sitecore OrderCloud geo-replication

The following diagrams (Figure 2 and 3) show Sitecore OrderCloud's platform architecture.





Sitecore OrderCloud is fully hosted on the Microsoft Azure Platform and has implemented appropriate technical and organizational measures designed to secure personal data from accidental loss and unauthorized access, use, alteration, and disclosure. Security is enforced via the Azure Security Center, which tracks, monitors, and alerts on irregular behavior or insecure settings across apps, storage blobs, SQL, active directory, etc. Utilizing Azure's SQL geo-replication service, data is replicated from the primary region to the Azure-paired region.
